### Minutes

Mayor Schindler called the Regular Meeting to order and led the Pledge of Allegiance.

Those present were as follows; Mayor Schindler, Mayor Pro Tem Debbie Sauls, Council Members Ronald Carter, and Jena Sandlin, City Clerk, Clerk Consultant, Maintenance Supervisor Patterson, Fire Chief Brown, Police Chief Breletic, and citizens.

First item of business was to discuss the City insurance quotes. Mayor advised that Council should discuss coverages. After much discussion and review of bids submitted, Member Sauls made a motion to go with American Public Risk policy with an annual premium of \$18,689 written through Blanton & Griffin. Member Sandlin second the motion, when question called all in favor, motion passed.

Mayor called on Contractor Mike Killeen to come forward to discuss the drainage issue on Essa St. Killeen described the drainage problem on Essa St. and then explained his bid on fixing the issue. He assured Council that this was not an absolute fix because a large rain could still cause issues for that area but this would remedy the problem at hand. After discussion, Member Carter made a motion to accept Killeen's bid of \$3500 to install a catch basin with frame and grate, minimum of 8" pipe and to clean the remaining drainage ditch to the end of Essa St. to be paid for from SPLOST VII, Roads/Bridges. Member Sandlin second the motion, all in favor motion passed.

Mayor called on Mike Hickman to come before Council to discuss his request for additional cemetery plotting in the Lake Park Cemetery. Mr. Hickman came before Council and withdrew his request. No action taken by Council.

Mayor stated no information had been obtained in reference to the DOT information on Ponds/Trails. Item will be put on March 7, 2017 Regular Meeting agenda.

Mayor requested the quotes for the Safety Signs to be paid for from SPLOST VII to be put on the agenda for March 7, 2017 as well. No action taken.

Mayor asked for Council to discuss the lighting upgrade to the city. It has been noted that there was an immediate need to upgrade and install new security lighting throughout the city as recommended by LGRMS (Local Government Risk Management Services). Member Carter made a motion to approve the purchase of 3 solar lighting kits at \$260 each, to be paid for from SPLOST VII funds. One being paid from SPLOST VII Public Works, one from SPLOST VII Administration, and one paid from SPLOST VII Parks & Recreation.

Mayor then discussed the City Verification with Counterclaim and/or Cross Claim regarding the Judicial Resolution of Service Delivery Strategy and other Relief. Member Carter made a motion to authorize the Mayor is sign for the verification in the forgoing Respondents' Verified Answer, Counterclaim, and/or Cross Claim to Petition for Declaratory and Equitable Relief . Member Sandlin second the motion, and when question called, all in favor motion passed.

Being no further business, Member Sandlin made a motion to adjourn, Member Carter second, and in favor, motion passed. Meeting adjourned at 7:45 PM.
