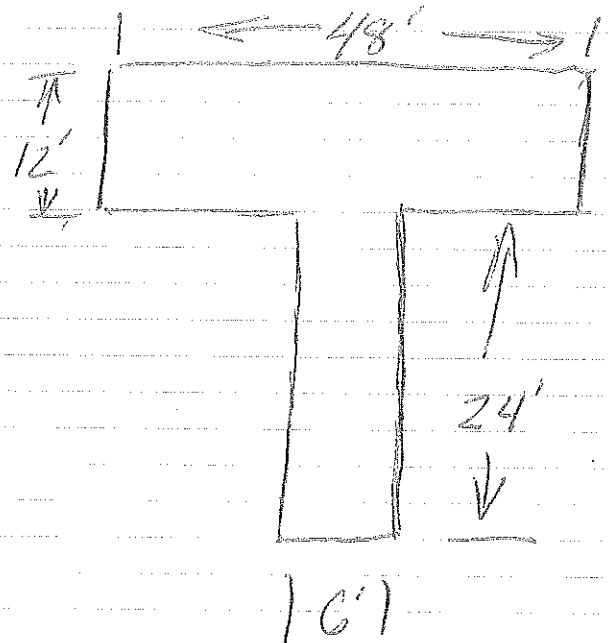

- Plantings of any kind are not allowed except by city personnel. Planting requests should be made to the clerk's office.
- The City of Lake Park reserves the right to remove all plants or arrangements after such time that the plant or arrangement has become unsightly in the opinion of the city staff.
- Funeral flowers will be removed from the grave approximately five (5) days after the funeral. If the family wishes to keep those arrangements they need to be picked up before the 5th day.
- The use of wire, iron, or metal stands, rocks, breakable containers or figurines on graves are strictly prohibited. These items create hazards for maintenance personnel, visitors, and equipment. Before any decorative items are installed or placed, please consult with City of Lake Park personnel.
- Even though we accept no responsibility for missing flowers, vases or other items, we would appreciate you reporting this to the City of Lake Park clerk's office.

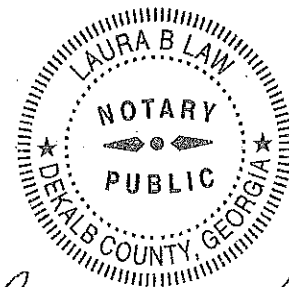


