7:30 PM

Mayor Schindler called Council Meeting to order at 7:30 PM and began with the Pledge of Allegiance followed by an invocation.

Those present were as follows; Mayor Schindler, Mayor Pro Tem Ronald Carter, Council Members Paul Mulkey and Bert Rutland, City Clerk, Police Chief Breletic, Fire Chief Brown, Maintenance Supervisor Patterson, and citizens.

Mayor asked Council to review the minutes from February 3, 2015 and February 12, 2015. Member Carter made a motion to accept the minutes as printed, Member Rutland second, all in favor motion passed.

Mayor asked Council to review the financials from January 2015. Member Carter made a motion to accept the financials as presented, Member Mulkey second, all in favor motion passed.

Member Carter made a request to add Ordinance 109 to the agenda, all agreed agenda item added.

#### Citizens' Concerns

Laura Minchew, 5840 Rivera Prada St, Memorial at Tom's Pond Sylvia Sanders, 308 Collins Ave, needed repairs to Essa Street Paula Gonzales, 307 Essa St, needed repairs to Essa Street

Mayor called for review and reading of Resolution # 2015-03-10, Tischo LLC. This is a resolution made by City Council of the City of Lake Park, to outline support for the proposed Lakeview Gardens project and for other purposes. After discussion, Member Rutland made a motion to support the endeavor by Resolution # 2015-03-10, Member Mulkey second, all in favor, motion passed.

Mayor asked Council to review the submitted bid for the Essa St. repairs. Member Rutland made a motion to accept the bid from Killeen Construction to do repairs to Essa Street in the amount of \$6200 being paid from the SPLOST VII account. Member Carter second the motion, all in favor, motion passed.

Mayor requested the sealed bid on the Civic Center moving/renovation (ADA compliant). The bid submitted was from Harper & Son and was in the amount of \$12,500 to move the Civic Center from Essa St to Tom's Pond. Member Rutland made a motion to hold off on Civic Center moving/renovation until Council could gather more information, Member Mulkey second, all in favor motion passed.

## Department Reports

Fire Department Chief David Brown was called to give his department report. He also added to remind Council of the City of Lake Park Employee/Representative Breakfast that the Fire department would host on Saturday April 4<sup>th</sup> at 9:00 at the fire station.

Police Department Chief James Breletic was called to give his department report. (See attached)

Per request of Chief Breletic, Member Rutland made a motion to cancel the officer's cellular phones and use that money to activate the fingerprint ID setup of \$250, Member Mulkey second, all in favor motion passed. Member Rutland requested that Chief Breletic turn in a receipt or ticket of some kind for the \$10 that he used to pay for the \$4,000 machine that the Chief had appropriated from the City of Valdosta.

Member Rutland made a motion to approve the advertisement in the Valdosta Daily Times for a full time officer and non-paid reserve officer with a deadline for submission to be March 31, 2015, Member Mulkey second, all in favor.

Member Rutland made a motion to approve the purchase of 2 plane tickets and per diem for Chief Breletic and Chief Brown to travel to pick up police car and put a spending cap of \$26, 500 to be paid for from SPLOST VII, Member Mulkey second, all in favor motion passed.

Maintenance supervisor Jeff Patterson was called to give his department report which included information about the meter change outs that are currently being done, water tank inspection on Friday March 6, 2015 that made it necessary for the city to be on county water service for approximately 8 hours, and to report a citizen complaint about a dead tree at 318 Broadway St that is dead at the top and hollowed out. Council advised to contact Pro Tree for inspection and quote on removal.

Mayor called for discussion of the proposed Court Accountant. Agenda item tabled at this time.

Mayor called for discussion of the proposed court ad-on fees. Agenda item tabled at this time.

Mayor called for review of the Herb Wyatt letter regarding the condition of Tom's Pond, Clerk read letter aloud. (See attached)

Mayor asked Council to review Ordinance 109 that was added to the agenda earlier by Member Carter. Member Rutland made a motion to table for further information and time to review, Member Mulkey second, all in favor, motion passed.



## AUTOMATIC AID FIRE PROTECTION AND ASSISTANCE AGREEMENT

This Agreement (the "Agreement") made and entered into effective as of March 24, 2015, by and between the City of Lake Park, Georgia (the "City") and the Board of Commissioners of Lowndes County, Georgia (the "County");

#### WITNESSETH

WHEREAS, the parcels of property fronting and in the environs of Enoch Lake Road and Enoch Lake Circle hatched on Exhibit A hereto (collectively, the "Property") are located in the unincorporated area of Lowndes County;

WHEREAS, the County and various current respective owners of the Property desire the City fire department to automatically aid and respond to and provide assistance in preventing and suppressing fires and with related protection of life and property located within the Property (collectively, "Automatic Aid Fire Services");

WHEREAS, the City desires, approves and directs its fire department to provide such Automatic Aid Fire Services within the Property; and

WHEREAS, Article IX, Section II, Paragraph III(b) of the Constitution of the State of Georgia provides that no municipality may provide fire protection services outside its boundaries except by contract with the county or municipality affected;

NOW THEREFORE, it is hereby agreed as follows:

- 1. The County requests and approves that the City fire department may provide Automatic Aid Fire Services within the Property.
- 2. The City approves and directs that its fire department shall provide Automatic Aid Fire Services within the Property.
- 3. The County agrees that it will cause the County's E-911 Center to code its emergency dispatch information for the City fire department to be dispatched to provide Automatic Aid Fire Services in the event of a fire or related emergency within the Property.
- 4. The City fire department shall respond to and provide the Automatic Aid Fire Services for a specific fire or related emergency event to which it is dispatched within the Property, unless and until the County fire department arrives at the location of such specific event and the City fire department specifically advises the County fire department thereafter to take primary command and control of the provision of fire protection services for such specific event; provided, however, the County may request that the City fire department remain at the specific event to assist the County in providing the fire protection services for such specific event.

- 5. Whenever the members of the City fire department or City employees are responding to or rendering aid or assistance pursuant to this Agreement, each shall have the same powers, duties, rights, privileges, and immunities as if they were performing their duties for and within the City of Lake Park.
- 6. Whenever responding to or rendering aid or assistance pursuant to this Agreement, the City shall furnish at its expense its equipment and personnel, and shall bear the loss or damage to such equipment and shall pay the expense incurred in the operation and maintenance of such equipment and for any injury or death to such personnel, and in each case shall indemnify and hold the County harmless therefrom.
- 7. Whenever responding to or rendering aid or assistance pursuant to this Agreement, the City shall compensate and shall defray the actual travel and maintenance expenses of the City's equipment and employees during the time they are rendering aid.
- 8. This Agreement will remain in effect until either party decides to terminate it. Either party hereto may terminate this Agreement at any time by giving sixty (60) days' prior written notice of such termination to the other Party to this Agreement; provided, however, this Agreement shall sooner terminate automatically as to all or any portion of the Property that may be annexed into the City.
- 9. This Agreement may not be modified, altered, or amended except by written agreement of the Parties hereto.
  - 10. Time is of the essence regarding this Agreement.
- 11. This Agreement contains the entire agreement between the Parties hereto with respect to the matters set forth herein.



Dear Mayor Sandlin:

A check of Tom's Pond was made, and as expected, the fish population is very low. This is primarily due to the low fertility of the extremely acid peat and coarse sand bottom. The application of the ground limestone will reduce the acidity of the bottom soil and make the lake much more productive. This process works slowly but during this year the change will begin and the fish population will start to expand.

The bass are the most abundant game fish at this time but their physical condition is poor because of the lack of food. Bluegill (bream) are the most important food for the bass, but the numbers of spawning sized bluegill are so low that they can not produce an adequate amount of food for the bass.

Increasing the productivity of the pond will favor a higher number of bluegill and improved food supply for bass and crappie.

We saw only two crappie (speckled perch). Crappies eat small fish and directly compete with the bass for food. Bass usually dominate this combination, so crappie will not increase until there is a better forage base of small fish for the bass and crappie.

I am hoping the lime will result in an improvement in the fertility to the extent that the pond will support a growth of plankton. These (usually) single cell algae give fertile water a green color. If this happens this year, we can stock threadfin shad. This small fish that has been widely stocked in the south over the past twenty years. The threadfin shad is native to the lower Mississippi River drainage south of Tennessee and were not found this far east until introduction to large reservoirs in Alabama, Georgia, Florida, parts of Tennessee and the Carolinas. More recently, they have been stocked in private ponds as a forage fish for bass and crappie with great success. They do not compete with other game fish for food as do other fish such as golden shiners (roaches).

If Tom's pond does develop an adequate level of plankton, we can stock threadfin shad this year and improve both quality and quantity of fish.

It is likely that fishing restrictions will need to be made in the future. Stringer limits should be set. Deciding the numbers is always controversial, but all reasonable people agree that fair distribution is necessary to maintain the fishing. In addition to limiting the catch, size limits should be considered. I recommend strongly that all bluegill, crappie, shellcrackers and warmouth less than 5 inches long should be returned. Additionally, no live bait fishing for bass should be allowed. When other fishing restrictions are to be considered, I would be available to make other recommendations.

We saw a few water hyacinths that had been hidden from the spray by the grass. I will treat these early in the spring at the appropriate time.

With the weed treatments last fall, I tried to spray a pattern allowing clumps of certain weeds and grass around the edge. The large pickerel weed, maiden cane grass and lily pads are attractive and are used as cover for fish. This is especially good for bank fishing as it brings fish to the edge. All plants, such as the water hyacinth and others that can interfere with the use of the pond will be controlled.
