Call Meeting Minutes

Mayor Schindler called the meeting to order at 6:32 PM. Those present were as follows Mayor Schindler, Mayor Pro Tem Debbie Sauls, Council Members Carter and Sandlin, Clerks, Police Chief Breletic, Fire Chief Brown, and Maintenance Supervisor Patterson.

Mayor led the Pledge of Allegiance prior to the beginning of the meeting.

Mayor called for Fire Chief David Brown to come forward to discuss the expenses projected on the tanker. Chief Brown stated that he estimated the total cost to convert the tanker from fuel to water, tires, and everything else except radios would be approximately \$17,672.

He also stated that the fire department brush truck was giving trouble again and that Council might want to consider selling it to further more expenses on it. He stated that there was one payment left on the truck of about \$8,000 but felt sure that the truck could be sold for about \$30,000. He stated that another municipality could maintain the brush truck a lot better financially than we could and then they could look at getting another one later on down the road. After discussion Member Carter made a motion to post the brush truck for sell with a minimum bid of \$30,000 as well as after final payment being made all revenue to be returned to the SPLOST VII fund. Member Sauls second, all in favor motion passed.

Mayor asked for Council to make a decision on the tanker expenses. Member Carter made a motion to allocate \$17,672 from SPLOST VII to get tanker upgraded to the obligated condition set forth in the agreement, Member Sauls second Member Sandlin oppose, motion passed.

Mayor called for Maintenance Supervisor Jeff Patterson to come forward to discuss the tree bid. After reviewing photos of trees and the city right of way maps, Member Sauls made a motion to contact city surveyor to help determine city lines and right of ways, Member Sandlin second, all in favor.

Member Sandlin made a motion to put off the tree item until the results from the surveyor and received and reviewed by Council, Member Carter second, all in favor motion passed.

Being no further business, Call Meeting adjourned at 7:30 PM.
