PUBLIC HEARING

April 1, 2014

This Public Hearing for case # LP-2014-26, Brookhaven III rezoning from C-C to R-6 was called to order at 7:50 pm by Mayor Schindler. Those present, Mayor Schindler, members Carter, Mulkey, Rutland and Sherrill, City Attorney, City Clerk and a large number of residents from Francis Lake, Hammock Lake and Horselot Lake.

Mayor Schindler requested Mr. Todd Miller of the Southern Georgia Regional Commission speak regarding the recommendation from the Greater Lowndes Planning Commission meeting March 31, 2014. Mr. Miller reported the Staff had recommended approval of the request, as it was appropriate for land use in area, and any drainage issues would be handled during the building permitting process. He advised Council that The Greater Lowndes Planning Commission voted unanimously to deny request. Mayor Schindler read opening statement that each side (opposing/for) would be given a total of ten (10) minutes to express their concerns, and opened the floor for those OPPOSED, Mr. Danny Ganas, Rev. Eldridge Lyons, Dr. Glenn Tucker expressed concerns over two story buildings, increased vehicle/foot traffic in area, possible decreased property values, crime, issues, etc. A petition with 95 signatures opposing the development was given to Council during the hearing. Mr. Dwayne Carson read a poem, and stated someone needed to speak out for the homeowers. Floor was then given to FOR rezoning, Mr. Bill Holland, attorney for the developer asked Council to

table the vote for 30 days, so that Council could obtain more information on the project.

There being no further comments, hearing was closed at 8:10 pm

Minutes

Mayor began by leading the Pledge of Allegiance followed by an invocation.

Mayor called Public Hearing called to order at 7:30 PM. Public Hearing agenda items were read, and discussed. Public Hearing closed at 8:05 PM.

Member Sherrill made a motion for Council to vote on Public Hearing items, Member Rutland second, all in favor motion passed.

Member Sherrill made a motion to approve and accept the Public Hearing item number one, Agreement For the Conveyance of Abandoned Right of Way, Member Rutland second, all in favor motion passed.

Member Rutland made a motion to approve and accept the Public Hearing item number two, LP-2014-01 Text Amendments/Land Use Table. Member Sherrill second the motion, all in favor motion passed.

Member Rutland made a motion to table Public Hearing item number three, LP 2014-02-26 Rezoning/Brookhaven, to set up an additional Public Hearing between the property owners, contractors, and concerned citizens. Member Mulkey second the motion and Council Member Sherrill requested discussion. When question called Members Rutland, Mulkey, and Carter for Member Sherrill oppose, motion passed.

Mayor stated Public Hearing item number four was withdrawn.

Council discussed and set Monday April 28th 2014 at 7:00 PM for a Public Hearing to gather additional information and allow concerned citizens to voice their opinions. The Hearing is tentatively set to be held at the Lake Park Civic Center providing adequate seating room.

Mayor called for a 5 minute recess.

The Regular meeting was called back to order at 8:42 PM.

Mayor called for review of the March 4 Public Hearing minutes and the March 4 2014 Regular Meeting minutes. Member Sherrill made a motion to accept both March 4 Public Hearing minutes as well as March 4 Regular Meeting minutes. Member Carter second the motion, all in favor, motion passed.

Mayor called for review of the March financials. After review Member Carter made a motion to accept the March financials as presented, Member Rutland second, all in favor motion passed.

Mayor called for Citizens' Concerns.

Christy Brownell, Lake Park Business Owner and Lake Park Chamber of Commerce President, wanted to thank the City Mayor, Council, and Police Chief for all their help with the Chamber Rodeo Parade and the Rodeo. Brownell stated that thanks to the City's help, both events were a great success.

Jeff Patterson, Ricks Street, wanted to thank the Mayor and Council for their support of the City and for their leadership during the Public Hearing.

Mayor called for the Council to make their suggestion for the Council Representative for the Ethics Committee. Member Carter made a nomination of Chad Greene of 609 Sheavette Rd., Member Rutland second all in favor, nomination approved.

Mayor asked City Clerk to read the Purple Heart City Proclamation. (see attached)

Mayor called for discussion of fertilization for Tom's Pond by Herb Wyatt. Council discussed previous services provided to the City of Lake Park by Mr. Wyatt. Member Sherrill made a motion to allow Mrs. Wyatt to do the fertilization service for up to \$70 an acre, Member Rutland second, all in favor, motion passed.

Mayor called for discussion on a possible Pavilion for Tom's Pond. No action taken.

Mayor discussed the need of 3 main water valves that are not in working order. Clerk was asked to contact Lovell Engineering to set up a day to come down to inspect said valves.

A PROCLAMATION HONORING THE MILITARY ORDER OF THE PURPLE HEART AND THE SERVICE MEN AND WOMEN OF THE CITY OF LAKE PARK

The Purple Heart is the oldest decoration in present use and was initially created as Bade of Military merit by George Washington in 1782; and,

WHEREAS, the Purple Heart was the first American service award or decoration made available to the common soldier and is specifically awarded to any member of the United States Armed Services wounded or killed in combat with a declared enemy of the United States; and,

WHEREAS, the City of Lake Park pledges to support those who serve through which together, we build strong communities.

"PURPLE HEART CITY IN THE STATE OF GEORGIA"
