Mayor Pro Tem Oscar Griffith called the meeting to order and lead off with an invocation.

Pro Tem Griffith called for department reports;

Fire department report was read aloud by Griffith, see attached. No action taken.

Maintenance department report was read aloud by Griffith. Pay rate increase to \$15.00 for Patterson and Jones was asked to be put on the Regular Meeting agenda for a vote, see attached. No action taken.

Police department report was read aloud by Griffith, see attached. No action taken.

Mayor Pro Tem Griffith called for Cemetery update. No action taken.

Pro Tem Griffith called for Veterans Memorial update. Julie Wilbers came forward to request Council approval to hold a Memorial Day service on May 30, 2022 at 9:00 AM at the Veterans Memorial. She also explained the request to designate the area at Tom's Pond as the Tom's Pond Veterans Memorial. Bob Wilbers also addressed Council as to the future plans and next steps for the memorial. No action taken.

Mayor Pro Tem Griffith called for review of the digital sign bids. Council agreed that they would like to see a photo or drawing. No action taken.
